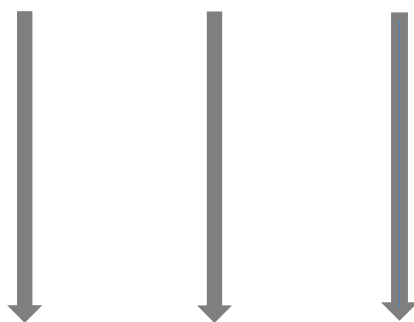

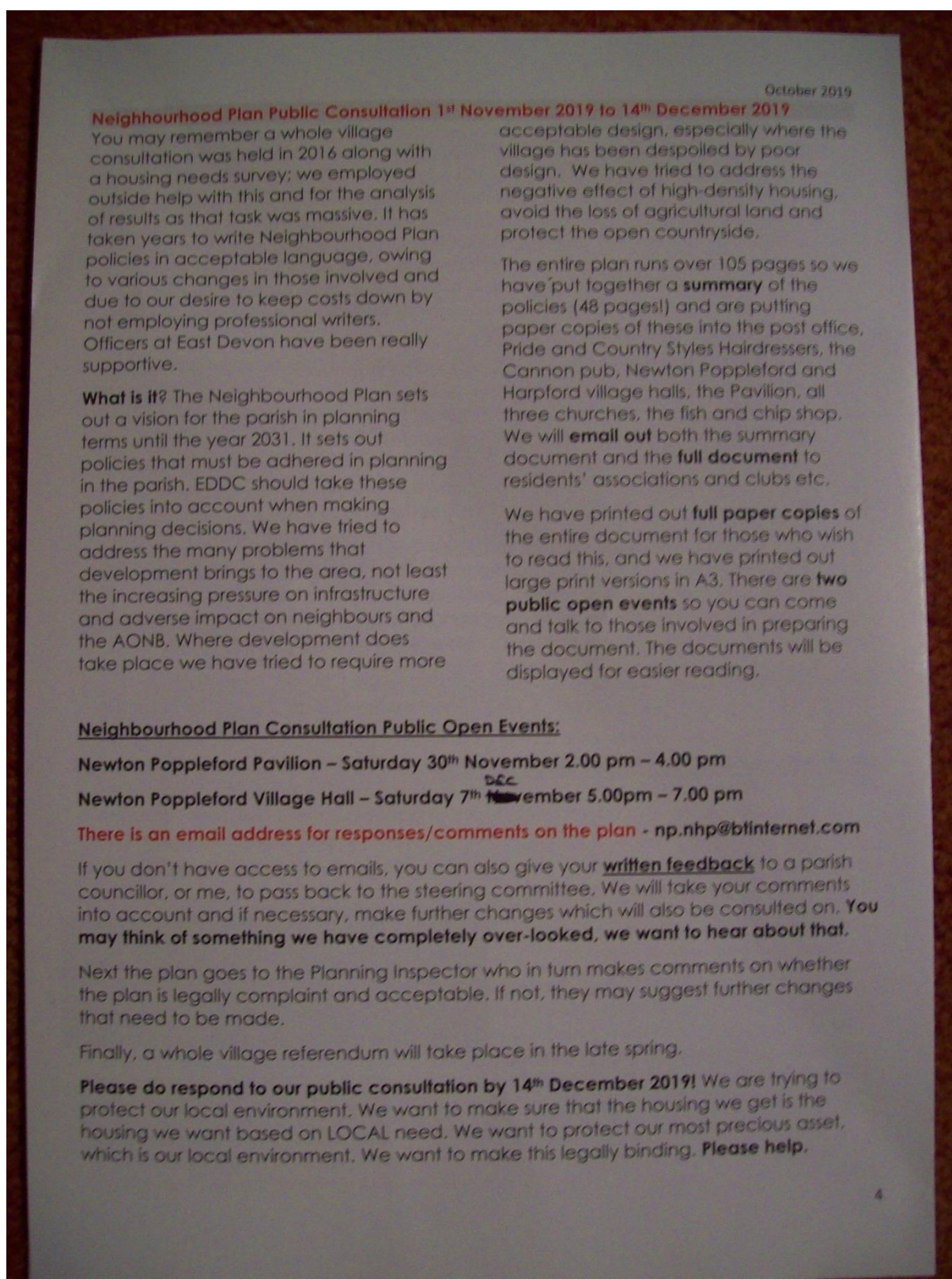

Neighbourhood Plans are legal documents which will hold great weight when the Parish Council and East Devon District Council decide planning applications, so it's important that ours is right.

There will be a six-week Public Consultation between 1st November and 14th December to give you plenty of time to read the plan and to make comments.

The Neighbourhood Plan is on the Parish Council Website (www.newtonpopplefordpc.co.uk) and paper copies are in several locations (see poster below).

You can see the plan and ask questions at two Open Days (on 30th November in the Pavilion, 2.00pm - 4.00pm and on 7th December in the Village Hall, 5.00pm - 7.00pm).

Also, you can choose to read either the full Plan or a shorter Summary. So what's the difference? The summary plan contains all the policies that will be applied to planning applications but the full plan contains all the background information as well.

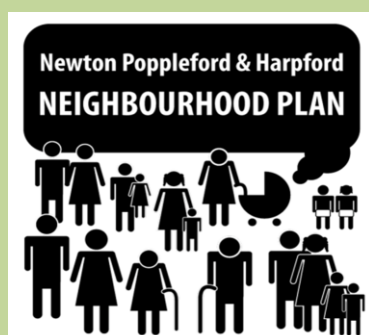
