It has a lengthy history starting life as Taunton Vale Gliding Club at Dunkeswell Aerodrome, before changing name and then buying some farmland one mile to the west on the edge of the Blackdown Hills, and developing a glider site at North Hill airfield.

In 2019, our site, North Hill airfield, was designated by Sport England as a gliding National Significant Area for Sport (SASP). In fact, we are currently making plans to hold a National Gliding Competition at North Hill in July 2023. - this will be the 50th Anniversary of the Competition Enterprise having been inaugurated at North Hill in 1973.

- Up to 20 homes – Amenity green space for informal play

- 21-100 homes – LAPs and amenity green space

- 100-300 homes – LAPs, LEAPs and amenity green space
- 300-500 homes - LAPs, LEAPs, amenity green space and other types

- Over 500 homes – LAP, LEAP, NEAP, informal play, amenity green space, and additional green space types.

3.56 Additional requirements for developments over 200 homes include:

- Doorstep accessible Greenspace (0.5ha within 200m) or;

- Local accessible Greenspace (2ha within 300m). For sites over 300 homes, Neighbourhood Accessible Greenspace (10ha within 1km) is required.

- Open space will be calculated based on an average of 2.26 residents per household, with some exceptions or contributions to off-site spaces allowed.

3.57 The draft LP policy provides some flexibility for diverting from the open space requirements, in instances where: the resident population may give rise to particular types of public open space; other substantive types of open space types are present; the site is constrained by size, the most meaningful contribution is generated by providing only certain types of public open space provision.

3.58 We support the Council's recognition that a flexible approach is required, however, at present, consider that the draft LP policy does not go far enough to recognise that there are other matters that influence the open space typologies that could be delivered on a site. This includes physical constraints such as topography and site context. Officers must acknowledge that certain sites are not suitable locations for accommodating certain types of public open space, especially formal sports provision, which requires specific topography

and gradients. Sporting facilities can, however, be delivered in other, informal ways, including the provision of outside trim trail equipment, circular walking routes, which can deliver similar benefits and provide opportunities for health and well-being to all.

The provision of additional open space, above the Fields in Trust derived standard, would not only add cost to the development but also reduce the developable area of the site to overcome deficiencies of the wider area, which aren't specific to the proposed development.

4.134. For sites such as Land to the South of Littleham, developers will be expected to provide an audit of existing open space provision within 1.5km of the development and the site's capacity to meet site open space requirements as well as provide on-site Local Areas of Play (LAPs), Local Equipped Areas of Play (LEAPs), amenity green space and all other open space typologies.

4.135. Moreover, all developments of 200 plus dwellings should also seek to ensure that there is, or will be, a Doorstep Accessible Greenspace (defined as any formal/ informal publicly accessible open space) of at least 0.5ha within 200 metres (under 5 mins walk), or a Local Accessible Greenspace of at least 2ha within 300 metres (5 mins walk from home). Additionally, developments of over 300 dwellings should provide, or have access to, a medium sized Neighbourhood Accessible Greenspace of at least 10ha) within 1km (15 minutes' walk from home).

It is unclear in the policy, as to how this will impact on open space and how this will be taken into account in the policy. There also appears to be little consideration of the viability of providing this level of open space, particularly, when considering all of the other different pressures on site infrastructure (and associated potential financial contributions). It is felt that the requirements – as set out in this policy – could be considered to be an extra burden on the developer.

4.139. Bloor Homes supports the direction of this policy and intends to align the development of Land to the South of Littleham in accordance with its requirements but they urge the Council to add more flexibility to the policy and to make allowance for site-specific provision in an alternative form. This will avoid the provision of open space to become an additional burden to home builders as they provide for much needed new housing.

4.140. Bloor Homes support this policy but suggest amendments to its drafting to provide for more clarity and flexibility.

The requirement for applicants on schemes over 200 dwellings to undertake their own audit of existing open space and its capacity is unreasonable. As above, it is for the Council to maintain its evidence base, against which applicants can design their individual schemes.

It will be challenging for all schemes of more than 300 homes to incorporate all the open space typologies listed in the table, especially formal playing pitches. No evidence has been presented by the Council to justify the effect of this blanket requirement on the delivery of new homes and other scheme elements and ultimately,

the effect on viability and the ability to deliver a policy compliant level of affordable housing. Coupled with this is the requirement for playing pitches to be within 1,200m of all dwellings within a scheme. Again, this is where the Council's quantitative and qualitative evidence should identify opportunities for improvements to existing facilities through commuted sum payments, where on-site formal sports provision is not appropriate.

Additional requirements for residential developments over 200 dwellings

These additional requirements for development over 200 (and 300) dwellings are unduly onerous and will be very challenging to achieve. Moreover, they have not been justified and tested against housing delivery and viability criteria, especially in lower value areas such as Axminster.

The requirement for schemes of over 300 dwellings to provide 10 ha of Neighbourhood Accessible Greenspace within 1km of each home may well be a laudable objective but it is simply unrealistic and unachievable. The

implication is that applicants will have to purchase an additional 10 ha of land adjoining or near to the site in order to meet the requirement. Policy OS02 has the clear potential on create a ransom in circumstances where

an applicant is forced to acquire additional 3rd party land in order to satisfy open space requirements. Planning policies should act in the public and should not serve private interests. As above, no assessment has been

undertaken of the effect of this requirement on scheme viability.

The requirement for schemes of over 300 dwellings to provide 10 ha of Neighbourhood Accessible Greenspace within 1km of each home may well be a laudable objective but it is simply unrealistic and unachievable. The implication is that applicants will have to purchase an additional 10 ha of land adjoining or near to the site in order to meet the requirement. Policy OS02 has the clear potential to create a ransom in circumstances where an applicant is forced to acquire additional 3rd party land in order to satisfy open space requirements. Planning policies should act in the public interest and should not serve private interests. As above, no assessment has been undertaken of the effect of this requirement on scheme viability.
