Key findings

1. Habitat creation and tree planting were identified as key drivers for delivering climate and nature recovery goals, as well as providing wider social benefits.
2. Education and awareness raising are seen as being key to delivering climate change and net zero, to ensure any solutions are equitable and fair across local communities and wider national benefits.
3. Water quality in our rivers and coast was picked up as a key action to improve the landscape, not just from a nature perspective but also for a variety of other reasons, e.g. recreational value, education, enjoyment, health & wellbeing.
4. There was desire to recognise other user groups of the Landscape, such as cyclists, to ensure that access and recreational/ecotourism opportunities are developed in partnership to cater for these user groups where appropriate

5. Call for greater financial support to encourage wider adoption of domestic renewable energy and supporting policy to facilitate this in new developments that reflect local community needs

Recommendations:

Generally, the feedback, where relevant to the Plan, was positive. Consensus was that the plan's ambitions and targets were laudable. All themes had majority support for the proposed objectives. A proportion of the comments received were in relation to service areas outside of our control and not within the remit of this Plan. These comments will be fed back to the relevant service area within East Devon District Council. Consultation responses support proceeding to formal adoption of the new Management Plan 2025-2030. The next review will be in 2030 for the period 2030-2035.
