GENERAL NOTICE OF REGISTERABLE INTERESTS

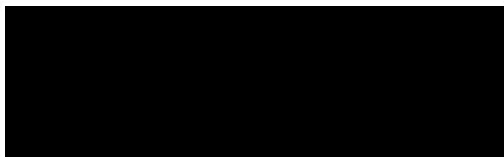
DECLARATION
