- The facility must be accessible to local residents and within reasonable walking distance for most users. Its size and scale should align with the needs of the community it serves.
- Development should promote shared spaces and facilities that cater to a variety of activities.

3.73 This policy is supported in principle but once again must be considered on a case-by-case basis. If additional community facilities are proposed as part of a new development, this should be considered and does not necessarily require such facilities to be in close proximity to existing built-up areas, noting that the additional footfall from new development could support a new community facility.

Object

Whilst we support the sentiment of this policy, “community facilities” need to be defined tightly on such a restrictive policy.

Moreover, there needs to be an understanding that on occasion there could be justification for the loss of a community facility because that loss would lead to greater social and/or economic and/or environmental gains that would justify the loss.

Reasons:

For such a restrictive policy, “community facilities” need to be defined tightly.

The tests do not include words effecting “unless it is proven that there would be other greater social and/or economic and/or environmental gains to justify the loss.”
