HBF do not support the inclusion of policies within a Local Plan that merely triggers a re-view of the Local Plan if monitoring shows housing delivery is not occurring as expected. Such a policy does nothing to address the housing crisis or undersupply of homes. There are other more effective and immediate measures that could be introduced into policy that would enable the Council to address housing under deliver, much more quickly than would be possible through the production of another plan, or plan review.

The Plan should include a more detailed Monitoring Framework which sets out the targets for housing (and other matters) that will be monitored and the triggers for action being taken, and what that action will be. Monitoring is essential to see if the Plan is delivery housing as expected. The monitoring framework is part of the way that the Plan delivers the flexibility is needed, so that the Council is able to respond to any changing circumstances.

125. It is important that houses are brought forward, and the matter addressed as soon as possible, if under delivery is observed. HBF would suggest, as a minimum, explicit reference should be made within the Plan's policy and monitoring framework to the potential to bring forward additional housing supply earlier. As the housing need and requirement figures for the Plan are minimum (not maximum) figures the Council could also specifically identify reserve sites and/or include policies that would allow for additional windfall housing sites that could/would be brought forward sooner to address any under delivery whatever the reason for that under performance. This could be a shortfall in market housing permissions granted and/or completions, affordable housing permissions granted and/or completions and any failure against the Housing Delivery Test or local plan monitoring.

Various monitoring reports are listed, but there is no reference to ongoing monitoring of the traffic and transport impacts of Local Plan implementation.

It is an objective of the Local Plan to promote sustainable transport, and we would therefore strongly recommend that additional reference is made to the monitoring of development Travel Plans and the outcomes of the emerging Greater Exeter Transport Strategy to ensure that the effectiveness of these strategies can be kept under review. Without such monitoring it will not be possible to determine whether the Authority has been successful in delivering increases in sustainable travel or whether further action is required to achieve the shift in travel modes.

Given the potential for the Second New Community site to have significant impacts for the SRN, we would also recommend that a comprehensive monitoring strategy be developed for the site to inform the phased build-out of development and parallel implementation of transport infrastructure improvements. Build-out of the development will take place over decades and assessment work to inform infrastructure requirements will need to consider a range of possible future scenarios. It is recommended that comprehensive monitoring of travel demands and transport outcomes should be undertaken to inform and review future development and infrastructure decisions.

The guidance on the consultation document states that the plan should be 'deliverable not aspirational'. The principle of potential for 'economic development' seems to be lacking in planning considerations. The Sidbury business park, seems a case in point, when years after approval, no developer has come forward to purchase and develop the land as a business park. There is a risk that 'history will repeat' with plan Sidm_34. In this case, numerous consultees have expressed concerns about the development, e.g. requiring archaeological digs before commencement, significant upgrading of drainage plans, negative impact on the AONB and the overall adverse nature of the site in a steep sided valley. Not only is there a risk that it will be a challenging site to develop, but that it will not be economical to do so. If approved the Council will no doubt 'tick off' 43 houses from their quota. However, this is totally disingenuous, if the land is never actually developed. The Council is delusional about their plan if applications will never result in the building of much needed homes, and should only include in the local plan, those cases that can be considered economically viable.
